

DEED OF VARIATION

The parties to this Deed are:

(1) **The Secretary of State for Education** ("the Secretary of State"),

- and -

(2) **Cambridge Meridian Academies Trust**, a charitable company incorporated in England and Wales with registered number 07552498 ("CMAT").

together referred to as the "Parties".

INTRODUCTION

- A. Sawtry Community College ("the Academy") is an academy operated by CMAT. It was previously operated by Sawtry Community College (company number 7773775) (the "Original Academy Trust").
- B. The Original Academy Trust entered into a single funding agreement with the Secretary of State for Education dated 27 September 2011 relating to the running of the Academy.
- C. CMAT took over the operations of the Academy from the Original Academy Trust on 1 April 2015.
- D. CMAT, the Secretary of State for Education, and the Original Academy Trust entered into a Deed of Novation and Variation of the Academy's single funding agreement, dated 26 March 2015, which varied the Academy's single funding agreement into a supplemental funding agreement ("Sawtry's Supplemental Funding Agreement") sitting under CMAT's master funding agreement dated 30 August 2013.
- E. CMAT wishes to change the name of the Academy to Sawtry Village Academy.
- F. The Parties wish to vary and amend the terms of Sawtry's Supplemental Funding Agreement to reflect the change of name of the Academy, and wish by this Deed, to record their agreement to such variations/amendments to Sawtry's Supplemental Funding Agreement.


LEGAL AGREEMENT

- 1. Any word or phrase used in this Deed shall, if that word or phrase is defined in Sawtry's Supplemental Funding Agreement, bear the meaning given to it in Sawtry's Supplemental Funding Agreement.
- 2. The Secretary of State and CMAT agree that with effect from the date of this Deed, Sawtry's Supplemental Funding Agreement shall be amended in accordance with the Schedule to this Deed.

3. As varied by this Deed, Sawtry's Supplemental Funding Agreement shall remain in full force and effect.


